

Sector committees



IFIA operates a number of Sector Committees, each of which deals with an area of specific product or market interest. IFIA also has three 'horizontal' committees – the Legal, Compliance and Accreditation Committees – which are of direct relevance to all members. All Committees report to the Council. How to join us

Membership of IFIA is open to testing, inspection and certification companies with international operations that can satisfy the IFIA Council they meet the membership criteria. Companies or other legal entities interested in IFIA membership may apply to the Director General for further information.

Applicants are required to print and complete an application form, which can either be downloaded from our website www.ifa-federation.org or obtained from our Secretariat. The application form should then be mailed to IFIA along with the application fee, which is currently £500.

Discussion with the Director General is strongly recommended prior to making a formal application. All applicants for IFIA membership are required to implement the IFIA Compliance Code, and members' continuing compliance is independently audited on an annual basis.
